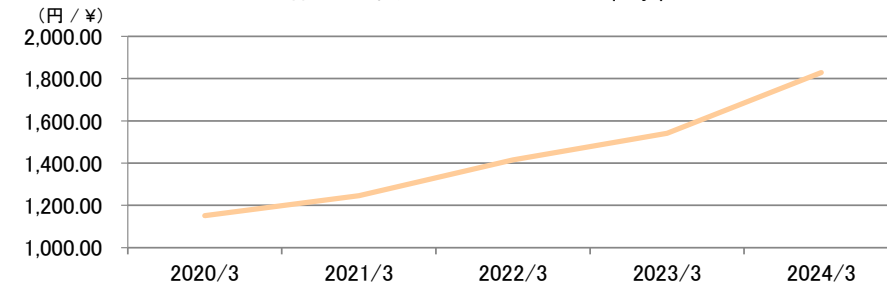

— 1株当たり純資産/Stockholders' Equity per Share

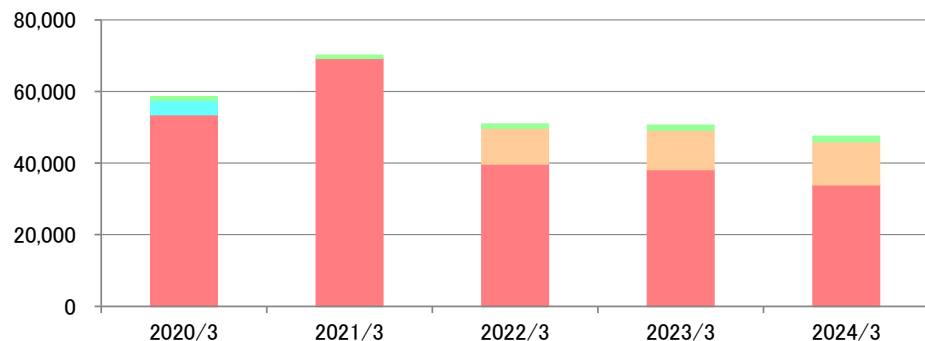
